


#### **Self-Nomination Form**

### **HOA Drop Box and US Mail Box**

There are two slots at the clubhouse in which either information for the Board may be placed by residents **OR** for the US Mail Carrier to place US mail for Edgewood. Please put **NOTHING** in the slot marked "US MAIL." In addition, dues or RV payments must **NOT** be placed in **EITHER** box.



### ... Water Leaks and Pest Control

If you find a water leak outside or near your property that is not caused by Edgewood irrigation, which is currently turned off, please call Citrus Heights Water District first. If they determine that a plumber is needed, please call a licensed plumber of your choice. The majority of water leaks are owner responsibility.

Also, pest control is owner responsibility.



### **Friendly Reminders**

- Now that the weather will be turning warmer, many residents will be opening their windows and doors.
  Please keep your voices down when walking near the fronts of buildings. Also, please be courteous and do not smoke near buildings as smoke can waft into open windows and doors. Please pick up your cigarette and marijuana butts.
- Please remember that plants, trees or potted plants should not be touching Association maintainence buildings and fences. These plants and trees should not extend into your neighbors' patios. All new trees are to be planted in pots so that they will not damage our shared drainage system, buildings or fences.
  Please let the Board and/or NCM know if plants or trees in the common area are touching fences or buildings.
- All permanent changes and/or additions to your buildings, patio area and front landscape must be approved via an Architectural Request Form submitted to the Board. New HVAC replacement units must have a licensed roofing company inspect the roof and determine that all recommended repairs to the roof caused by the installation were completed by the homeowner.
- The area where we keep our garbage, green waste and recycle containers is a designated common area.
  Only the three containers may be kept in that area.
  The gates that lead to the container areas from the allies should always be unlocked.
- When placed in the alley for pick up, the garbage, recycle and green waste containers should be three feet apart and not placed under the eaves. This may help prevent the garbage trucks from hitting our gutters. Unfortunately, we cannot prove the trucks are hitting them without proof or first hand witnessing of the event. If you see the trucks hitting gutters or ANY Edgewood property, please try to take a picture and report it to NCM and the Board.

#### **Gutter Cleaning**

Now that all the leaves have fallen, our gutters will be cleaned out and the downspouts will be flushed.

We have contracted with S and J Home Maintenance to do the job. The dates they are scheduled to be here are March 4-6. Although the crew tries their best not to drop debris in our patio areas, it is optional for you to leave your back gates open to allow them to clean up any debris that may have fallen into your patio area. Since there is only a 30-day warranty, it is imperative that you contact Pat Burden and NCM before April 5, 2024 if your gutters and downspouts were not cleaned to your satisfaction.
