Please remember there is absolutely NO glass in the pool area. Broken glass is nearly impossible to pick up from decking or the bottom of the pool.

Thank you everyone for keeping our pool area clean. Many thanks to you who swim in the evenings as you are helping to keep the ducks out of the pool! Please don't use the deadbolt locks in the restroom door to prop open the doors. This could damage locks or door

frames.



### Parking

We appreciate those of you who call in advance and request a parking permit for your guests.

Remember: you only need a permit if guests are staying for more than three days. Please call Pat Burden to request one, and it will be delivered to your home. Her number is also in the box below.

Please remember that all parking slots in the alleys and on Spyglass Lane are reserved for guests. Residents may only park in guest parking for very brief periods of time and only when necessary.

We have issued very few parking citations in recent months, and most have them have been for residents parking in guest parking.

#### Please Don't feed the Wildlife



Unfortunately, the board continues to get reports of residents feeding the ducks and squirrels here in Edgewood. Please do not feed any wildlife here. In the past, the ducks have fouled our pool on many occasions and that has cost the HOA thousands of dollars. Your cooperation is greatly appreciated.



#### **Patio Trees and Plants**

Kindly remember that plants, trees or plants in your patio area may not be touching Association maintained buildings and fences. Also, these trees or plants should not extend into your neighbors' patio areas.

All new trees must be planted in pots so that they cannot damage our shared drainage system, fences or buildings. Please let the board or management know if plants or trees in the common area are touching any buildings or fences.



### **Architectural Request Forms**

All permanent changes and/or additions to buildings, patio areas and front landscape must be approved via an Architectural Request Form submitted to the board.

Once the ARF is approved, work may begin. Examples are: new windows or doors, screen doors, porch lights, garage doors, or any changes to your patio areas,

New HVAC requests are expedited. After completion of the installation, owners must have an inspection of the roof by a licensed roofing contractor. This is to ensure that any repairs caused by the replacement are completed by the homeowner.

The roofer's report must be submitted to the board. The reason that the roof must be inspected is due to most roof leaks have been near HVAC units.

#### The Fining Process

We have been asked to explain how the board levies fines here in Edgewood. The following are the steps that are taken.

After a homeowner has received two violation letters for the same offense, the homeowner is called to a private meeting with the board in executive session. The homeowner is given the opportunity to explain their position regarding the violation.

Rarely has the board decided to issue a fine at this point. There have been very few hearings in the last several years, the last fine was issued in 2015.
